| 2 LOCAL, STATE & U.S. TRAFFIC LAWS: When operating a Movemint vehicle, I agree to follow all traffic rules and road regulations as stated by City of Austin, Texas State Law and U.S. Law I agree to hold all proper licensing documents relative to market location. I assume all legal and financial responsibility for penalties given if ticketed by a legal authority while at work. I will not hold Movemint responsible without reasonable cause. I understand it's my own responsibility to understand all laws in place and review city ordinances in place. |
| WAIVER OF LIABILITY: It is my sole duty to transport passengers to and from their destination safely. While at work, I will be a communicative, law abiding and a defensive driver while operating in public and private settings. I agree to NOT operate Movemint vehicles if I do not have the capacity to do so safely (i.e physically, mentally, emotionally/spiritually). It's my duty to serve all patrons and the public alike, with decency and respect. I will refrain from inducing or encouraging any violence, or crude behavior while at work. *Unacceptable behaviors include but may not be limited to badmouthing, spitting, pushing, hitting, fighting, assault, and/or making any type of sexual gestures to antagonize others. Movemint has a Zero tolerance for indecent behavior and may revoke my ability to work with them immediately, at the staff's discretion. I will not hold Movemint liable if I get into trouble for my actions while at work. I understand that Movemint staff may investigate any case to the depth that resolution and mediation is necessary amongst co-workers, peers, and the public alike. a.) I waive my right to hold Movemint responsible if an accident is to occur due my own driving errors. Under such claims, I am aware that Movemint may hold me responsible for all associated accidental costs. I assume responsibility to pay up to a \$2000 Insurance deductible, if I'm found at fault. I'm aware that as a driver, I have the option to seek my own liability insurance at my own expense. I am also aware of the pre-inspection checklist criteria that I am to address on my vehicle |
| every day before going to work. I will NOT operate the vehicle if it does not pass pre-inspection standards and guidelines. b.) I am aware that Movemint Bike Cab carries insurance for pedicab passengers and property if an |

| 5RESPONSIBILITY FOR PROPERTY: I am responsible for the pedicab I ride. It is my responsibility to avoid accidents at all costs. I will be held liable for any financial and/or physical damages caused to the vehicle, company and/or additional properties due to an accident where I, the driver, am at fault. So long as the vehicle is in my posession, I assume responsibility for accidental damages while pedaling, hauling or in tow. I agree to pay full price for accounted parts and service costs outside of normal wear and tear, where I am found at fault. I understand company service costs to be at a \$50 per hour rate, and parts to be priced relative to retail market standards-comparable to distributor retail prices. |
| 6 LIABILITY FOR LOSS OR TOTAL DESTRUCTION: In the event of loss or total destruction of the pedicab or the driver's inability to return the pedicab in whole undamaged condition for any reason, driver shall pay the company full replacement cost. I agree to carry and use an industry manufactured bike lock while I'm at work to prevent theft. |
| 7 PEDICAB DAMAGES OR MALFUNCTION: In the event of damage or malfunction of pedicab, (I) driver must Immediately notify Movemint staff and discontinue use of said vehicle. Movemint agrees that, within a reasonable period of time from receiving notification, based on the company's reasonable ability, to supply driver with a repaired or replaced pedicab working in safe order.
